Applications are invited from eligible male candidates who are citizens of India for filling up the following temporary posts of HC Driver and Mechanic (Group-C) in the Department of Arunachal Pradesh Fire & Emergency Services.

**2. AGE ELIGIBILITY :-**

The age of candidate should be between 18 to 28 years for HC Driver and 18 to 25 years for Mechanic as on 01/01/2015. The maximum upper age limit is relaxable upto 5 years for APST, 5 years for Sports personnel (General) and 10 years for Sports personnel for (APST).

*NB: The age relaxation in respect of Ex-Serviceman is explained at Sl. No. 5(ii)*

**3. PHYSICAL STANDARDS:-**

- (a) Height : i) APST & APST Ex-Serviceman – 160 cms.  
ii) APST & APST Ex-Serviceman hailing from Tirap, Changlang and Longding district - 152 cms.  
iii) General – 165 cms
- (b) Chest : Minimum-79 cms, Expanded-84 cms. The minimum expansion ability should not be less than 5 cms.

*NB:-The candidates should have sound health, free from any disease, physical deformity/infirmity like squint eye, knock knee, bow leg, dismembered fingers and any other physical deformity/infirmity/disease which is likely to cause impediment to perform active duty in Fire & Emergency Services. Any candidate with such deformity/infirmity will be rejected during the physical standard Test (PST). Both eye vision: Distance vision- better eye (corrected vision) should be 6/6, worse eye (corrected vision) 6/12. Near vision J1 (corrected) J2 corrected. No colour blindness.*

**4. EDUCATIONAL QUALIFICATION :-**

i) **HC Driver:-** Minimum educational qualification required for all candidates is Class- X pass or equivalent qualification from recognized Board/Institution and possessing of Heavy Motor Vehicle Driving Licence valid upto the date at the time of submission of application for the post.

**Desirable:** Experience of Driving Heavy Motor Vehicle for 3(three) years.

ii) **Mechanic:** - Minimum educational qualification required for all candidates is Class-X pass with I.T.I in Auto Mechanic or equivalent qualification from recognized Board/Institution.

**5. Eligibility conditions for Ex-Servicemen :- (HC Driver only)**

i) **Previous service :-** Ex-servicemen (APST candidates only) having completed their service tenure in Army/Assam Rifles/ITBP/BSF/CISF/CRPF/SSB with satisfactory service records and those who have taken voluntary retirement from the service with full benefit will be eligible.

ii) **Age:** - Age concession for Ex-servicemen will be allowed in accordance with the orders issued by the Govt. from time to time. After deducting military service from their actual age, resultant age should not exceed the prescribed age limit by more than 3 years as on 01/01/2015.

iii) **Physical efficiency/endurance test:** - Ex-servicemen candidates will be exempted from qualifying the Physical endurance/efficiency tests.

iv) **Others:** - The other conditions and criteria like physical measurement, educational qualification, Trade Test, written test and viva-voce etc., shall be same as in the case of APST candidates.
