1. **Reporting Date & Time:** only provisionally selected candidates shall report at Police Training Centre (PTC), Banderdewa on 09/03/2026 (repeat: 09/03/2026) between 0900 hrs to 1200 hrs.

7. No joining shall be entertained after the Zero week of training (i.e., 09/03/2026 to 15/03/2026), under any circumstances, except in exceptional cases with prior approval from PHQ, Itanagar.






