**IMPORTANT JOINING INSTRUCTIONS DURING THE REPORTING AT FSL PTC BANDERDEWA**

1. **Reporting Date & Time:** Only selected candidates for the posts Laboratory Assistant, (**Ballistics, Cyber Forensics, Questioned Documents, Finger Print, Biology/Serology, Narcotics**) shall report at Directorate of Forensic Science, Police Training Centre (PTC), Banderdewa on 16/02/2026 (repeat: 16/02/2026) between 0900 hrs to 1200 hrs.
2. No visitors or relatives of candidate shall be permitted inside the campus.
3. Candidates are strictly prohibited from bringing private/personal vehicles inside the PTC campus.
4. **Entry Point:** Entry into the campus must be through Gate No.1 of PTC, Banderdewa.
5. Documents Required at the Time of Reporting:
  - a. Offer of Appointment
  - b. Valid ID Proof
  - c. Two (02) recent passport-size photographs
  - d. Blood Group Report.
  - e. Medical fitness certificate from any Chief Medical officer, Govt Hospital, Govt. of AP
  - f. Certificates viz., Birth Certificate, Education qualification (all in Original along with photocopy).
6. **Bank Account:** All candidates must open a regular Savings Account in SBI (State Bank of India) with an ATM card before reporting to FSL, PTC. All candidates will have to submit their Account details during the time of joining.
7. No joining shall be entertained after **23/02/2026 (Monday)**.
8. **Leave Policy:** No leave shall be granted during the entire training period, except in cases of genuine emergency cases.

The appointment to the post of Laboratory Assistant (mentioned against their name) in the Directorate of Forensic Science, Govt of Arunachal Pradesh shall be subject to the following conditions specified below: -

- a) The appointee shall be on probation for a period of 02 (two) years.
- b) True and sufficient disclosure of the information while filling up each and every column of attestation form.
- c) A comprehensive Character and Antecedent verification of the candidate to the fullest satisfaction of the department. If any adverse remarks received about the character and antecedents, the service will be terminated forthwith.
- d) Production of a Certificate of Fitness from the Competent Chief Medical Officer, appointed/authorized by the Government of Arunachal Pradesh.
- e) Taking an Oath of Allegiance and Secrecy to the Constitution of India (making a solemn affirmation to that effect) in prescribed form on joining.
- f) Training as and when assigned to him/her by the Government must be successfully completed, failing which, probation period will be extended to that extent.
- g) Production of Release Order/NOC from the previous employer (applicable in the case of persons who are already in Government Service).

- h) Submission of Certificates in support of Age/Educational Qualification (Photocopy) on joining.
- i) Will be required to serve at least for 3 (three) years from the date of joining, unless discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said two years, he/she has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training institute. However, in the case of an individual who technically resigns from the Police Department before expiry of the said three years for joining same/higher grade post within the establishment of the Arunachal Pradesh Police Headquarters (Civil Police/AAPBn/IRBN) or Fire & Emergency Service, he/she shall be exempted from the refund of cost of training i.e. pay drawn during the period of training plus the expenses of TA to join the training school. Continuity of service in the Arunachal Pradesh Police will be requisite condition.
- j) He/She is required to serve anywhere in Arunachal Pradesh or outside the state where posted or detailed.

2. If any declaration given or information/document furnished by the candidates proves to be false/forged or if the candidate is found to have willfully suppressed any material fact, he/she will be liable to be removed from service and such other actions as liable may be taken by the Government.

4. No Traveling Allowance/ Dearness Allowances will be admissible for joining the place of posting.

The other terms and conditions of service which are not specified herein shall be in accordance as per the relevant rules in force from time to time.

The candidates willing to accept the terms and conditions mentioned above, should report alongwith written acceptance and documents to Directorate of Forensic Science, PTC, Banderdewa on **16/02/2026 repeat 16/02/2026 (Monday) at 0900Hrs or latest by 23/02/2026 (Monday)**. If no response is received within the stipulated time, it will be assumed that the candidate is not interested to accept the offer and the offer of appointment shall stand cancelled and the vacancy will be forwarded to APSSB, Govt. of Arunachal Pradesh.
