LIMITED TENDER NOTICE

1. Director General of Police, Arunachal Pradesh, invites sealed tender on plain paper from the manufacturers, authorized agents and dealers of reputed firms for supply and installation of the following Conference System items at New Conference Hall, PHQ, Itanagar during the year 2016-17. The sealed tenders will be received up to 1100 hrs on 24/03/2017 which will be opened at 1130 hrs on the same day. Tenders received after scheduled date & time will not be entertained. The tender value is Rs. 20.00 lakhs approx. The tenderers or their authorized representatives may remain present at the time of opening of tenders.

2. All the tenders must be accompanied with Earnest Money of Rs. 40,000/- (Rupees . forty thousand) only. Tenders without the Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate (NSC)/Kishan Vikash Patra (KVP) in the form of Earnest Money/Security Money in the name of the Head of Office i.e. AIGP (E) from which the work is being allotted to them. The tenderers within the state of Arunachal Pradesh should purchase the KVP/NSC from the Post Office located at Arunachal Pradesh. As per Govt. order No. DSS/ACCTTS/2/99-2000 dated. 17/03/2011 the tenderers outside the state of Arunachal Pradesh may purchase the NSC/KVP from the Post Office located at their location/state, but the same must be pledged to AIGP (E) PHQ, Itanagar, Arunachal Pradesh.

3. Successful tenderers will be required to deposit 5% of the total value of the articles to be supplied as security money within 7 days from the date of issue of letter of acceptance of tender. The successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the tender. Security money will be subject to forfeiture in case of non-fulfillment of any or all the Terms and Conditions of tender. Earnest Money of the successful tenderers will be forfeited to the Government in case of failure to furnish security money and execution of "DEED OF AGREEMENT".

4. Successful tenderers will have to supply the items within 60 days from issue of supply order, failing which 5% of the total value of the articles to be supplied will be forfeited and supply order cancelled. The stores supplied must be of the same specifications and quality as per the tender.

5. Rate should be quoted F.O.R. Central Stores, PHQ Itanagar Arunachal Pradesh by road transport (freight paid). Rates quoted other than F.O.R Central Stores; PHQ Itanagar shall not be accepted. No packing or forwarding charges will be allowed. The VAT/CST/Entry Tax (where or as applicable) may be charged by the tenderers and shown separately along with tendered rates of the article. The rates should be quoted both in figure and words clearly in Indian currency.
