LIMITED TENDER NOTICE

1. Director General of Police, Arunachal Pradesh, invites sealed tender on plain paper from the manufacturers, authorized agents and dealers of reputed firms for entering into contract for supply of the following equipments for Arunachal Pradesh Police during the year 2019-20. The sealed tenders will be received up to 1100 hrs on 24/03/2020 which will be opened at 1130 hrs on the same day. The tender value is Rs. 3.16 lakhs approx. The tenderers or their authorized representatives may remain present at the time of opening of tenders. The tenders received after scheduled date and time will not be entertained.

2. All the tenders must be accompanied with Earnest Money of Rs. 6,000/- (Rupees six thousand) only. Tenders without the Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate/ Kishan Vikash Patra/ TDR/FDR/Demand draft etc. of Nationalised Bank/Post Offices in the form of Earnest Money/Security Money in the name of the Head of Office i.e. AIGP (E) from which the work is being allotted to them.

3. The tenders must accompany with valid attested copy of GST Registration certificate.

4. The tenders must also accompany with valid license for trading of the tendered item.

5. The letter of authority in respect of authorized distributors/dealership must be furnished along with the tender.

6. The tenderer should quote for one model only of each item. Offer/quotation for more than one model will not be considered. Technical compliance statement should be submitted along with the tender clearly specifying deviation, if any, for all the specifications mentioned above. The tenderers should submit detailed specifications of the item along with the catalogue (Original)/ Booklets/ Literature/ Photographs etc.

7. The rates should be quoted in the tenders/quotations for the item (s) and GST separately. The rates also should be quoted for F.O.R. Central Stores, PHQ, Itanagar. Rates quoted other than F.O.R Central Stores; PHQ Itanagar shall not be accepted. No packing or forwarding charges will be allowed. The rates should be quoted both in figure and in words clearly.

8. Tenders should be addressed to the Asstt. Inspector General of Police (E) by designation and not by name. The sealed envelope containing quotation should be subscribed as "Tender for supply of equipments for Arunachal Pradesh Police for the year 2019-20" and be sent by Registered Post/courier or be put in the tender box kept in the office of the Deputy. Supdt. of Police (Prov), PHQ, Itanagar during office hours. ***The tenders received after scheduled date & time will not be entertained.***

9. Successful tenderers will be required to deposit 5% of the total value of the articles to be supplied as security money within 10 days from the date of issue of letter of acceptance of tender. The successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the contract. Security money will be subject to forfeiture in case of non-fulfillment of any or all the Terms and Conditions of contract. Earnest Money of the successful tenderers will be forfeited to the Government in case of failure to furnish security money and execution of "DEED OF AGREEMENT".

10. Successful tenderers will have to supply the items within 15 days from the date of issue of supply order/deed of agreement failing which 5% of the total value of the articles to be supplied will be forfeited and supply order cancelled. The stores supplied must be of the same specifications and quality as per the tender.

11. Quantities mentioned above are all approximation and subject to variation as per actual availability of funds.

12. Any breakages or loss of any item (s) enroute or in transit will be at the supplier's risk.

13 The successful tenderer has to demonstrate the items at the time of delivery. If the items are not found as per specifications, the entire lot will be rejected.

14. If any item is found damaged or otherwise unacceptable at the time of delivery/inspection, the suppliers will be required to remove the same from Central Store, PHQ, Itanagar Arunachal Pradesh at their own cost within 15 days. The equivalent replacement of approved quantity should be supplied within 15 days or the equivalent value in terms of money will be deducted.

15. Payment will be made to the supplier directly on completion of supplies and on receipt of stores. Document/Vouchers/R.R.S bill etc. routed through Bank will not be accepted.

16. The items supplied shall be on warranty for the periods as mentioned with specifications.

17. Tenders will remain valid up to 31-03-2021.

18. The Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all or any of the tenders without assigning any reason thereof.

19. The Director General of Police of Arunachal Pradesh Police shall have the right to ask the firms to demonstrate their items before the items are accepted.

20. In case of any dispute, legal jurisdiction will be at Itanagar, Arunachal Pradesh.

21. In case of any bandh call on the date of opening of tender, the tenders will be opened on the next working day.
