

### Terms and Conditions

1. The Superintendent of Police capital, Itanagar invites sealed tender on plain paper from Registered suppliers and reputed pharmacy for supply of the medical equipments for COVID-19 for 03(three) Police Station Itanagar, Naharlagun and Nirjuli as per specifications of this office. The sealed tender will be received upto 1600 hours on 23/12/2020 and will be opened on 24/12/2020 at 1130 hours. The tenderers or their representatives may remain present at the time of opening of tender.
2. Tender received after Scheduled date and time shall not be entertained.
3. Tender should be typed or hand written clearly in block letters. All literature or correspondence in connection with tender shall be made in English.
4. Tenders will not be accepted unless properly sealed. Tender sending through postal/courier shall reach to the addressee in good condition. Tender in torn condition will not be received.
5. (A) Envelope, containing tender shall be superscribed in block letters with the heading "TENDER FOR MEDICAL EQUIPMENT" FOR THE SUPERINTENDENT OF POLICE CAPITAL PAPUMPARE DISTRICT and should be addressed to the Superintendent of Police ,Capital ,Itanagar(Ganga), District Papumpare, Pin-791113.  
(B) Tenderer should write his full address at the bottom of the left side of envelope.
6. Correction(s) in the tender, if any must also be typed clearly or written in block capital letters in ink and duly initialed. Overwriting on the tender is liable to be rejected.
7. Tender once submitted shall be final. No alteration/modification in the rates and terms and conditions of the tenders shall be entertained after opening of the tender.
8. The tenders must accompany with valid attested copy of GST Registration certificate.
9. The tenders must also accompany with valid license for trading of the tendered item.
10. The tenderer should quotes for one model only of each items. Offer/quotation for more than one model will not be considered.
11. The Rates should be quoted in figures as well as in words and if GST or other taxes are not mentioned it will be taken as included in rates quoted.
12. Tender should be quoted in two bid system, the bidder have to submit their offer in two parts. Both the bids should be sealed in two separate envelops.  
**Part-I Technical Bid-** It shall contain EMD, documents related to qualifying requirement as per NIT, Technical details,terms and conditions, experiences, past performances, facilities at yards, financial position and other tender related documents in one envelop clearly super scribing NIT No. and indicating the contents inside the envelope.  
**Part-II Financial Bid-** It shall contain price bid only one envelop clearly super scribing NIT No. and indicating the contents inside the envelope.  
Price should not be indicated in the Technical Bid. Price should be quoted in Indian Currency.
13. **Tender Opening:-** The first envelop i.e. part-I, Technical bid shall be opened on the specific date indicated in the Tender documents. Credential and other related documents shall be evaluated and only the qualified tenderer will be considered.  
The Second envelope i.e. Part-II Financial bid shall be opened subsequently only in respect of those tenderers who qualified in technical bid by the committee.
14. Tender will remain valid upto 31/03/2021. Rates quoted will be final and will not be allowed to be increased during the validity period under any circumstances and for any reason whatsoever. Those who do not quote validity of rates upto the above mentioned date, their bids will be rejected.
15. The rates should be quoted for Itanagar destination. The price should be inclusive of all taxes, duties, insurance, transportation etc. whichever is applicable shall be shown separately.
16. The Tenderer shall not sublet the contract to any other Agency/Firm.
17. TDS/Income Tax against the supply order shall be deducted from the bills as per applicable rate.
18. The items supplied shall be on warranty for the periods as mentioned with specifications.
19. Successful tenderers will be required to deposit 2% of the total value of the articles to be supplied as a security money within 10(ten) days from the date of issue of letter of acceptance of tender. Security money will be subjected to forfeiture in case of non-fulfilment of any or all the terms and conditions of contract. Earnest/money of the successful tenderers will be forfeited to the Govt. in case of failure to furnish security money.
20. The Superintendent of Police, capital, Itanagar shall have the right to ask the firms to demonstrate their items before the items are accepted.
21. In case of any bandh call on the date of opening of tender, the same will be opened on next working day.
