The sealed tender should be submitted/dropped in the tender box in the office of Directorate, of Fire & Emergency Services, Ganga, Itanagar w.e.f. 24/06/2022 to 12/07/2022 till 5.00 PM on 12/07/2022 on all office working days and office hours duly marked " Tender for purchase of condemned vehicle with the vehicle number" on the top of the sealed cover. Sealed quotations will be opened on 13/07/2022 at 1100 hrs in the Office of Directorate, of Fire & Emergency Services, Ganga, Itanagar by the board of Officers. The representative of the tender may present at the time of opening of the tender.
2. The Tenderer should clearly mention the BID AMOUNT of offer in Figure and Words against the vehicle mentioned above separately for each vehicle. Quotations must be accompanied with Bid Security (Earnest Money) of Rs. 2000/- each (Rupees Two thousand) only against the vehicle No. AR01B-3739, AR-01J-0039 & Rs. 1000/- each (Rupees one thousand) only against the vehicle No. AR-01A-6795 and AR-01A-7763 in the form of Demand Draft/DCR in favour of Superintendent of Police, Fire & Emergency Services, Itanagar to be drawn at SBI, Itanagar without which the quotation will stand automatically rejected.
3. The Earnest money of successful bidder shall be refunded on payment of bid money in full. While that of unsuccessful Tenderer the same shall be released on completion of the auction.
4. The bid/quoted amount should not be less than the reserve price as above. If highest bidder withdraws after opening of the bid, his/her EMD shall be forfeited.
