TERMS AND CONDITIONS

1. The sale will be "AS IS WHERE IS BASIS" and in bulk (Total-552 Nos.). Interested purchasers can inspect the condemned tyres on working days from 0900 hrs to 1600 hrs with prior permission of the Motor Transport Officer, Police HQs Motor Transport Office located at Chimpu, Itanagar.
2. Every quotation should clearly state the amount offered (both in figure and words) along with earnest money of Rs.23,139 (Twenty Three Thousand One Hundred Thirty Nine) against the condemned tyres, to be deposited in shape of Demand Draft in favour of Superintendent of Police , Motor Transport Unit, Chimpu Itanagar, encashable at any Nationalized Bank of India.
3. The earnest money of successful bidders shall be refunded on payment of tender money in full, while that of the unsuccessful tenders shall be released on completion of auction process.
4. Interested bidders may put their quotations in the Tender Box kept at MT PHQ Chimpu. Itanagar during office hours w.e.f. 28.05.2026(1000 hrs) to 17.06.2026 (1600 hrs). The wax sealed cover envelope should be clearly marked "QUOTATION FOR CONDEMNED TYRES" addressed to the Superintendent of Police (MT), PHQ Chimpu. Itanagar. Arunachal Pradesh. The sealed quotation will be opened on 18.06.2026 at 1030 hrs and interested bidders may be present at time of opening in the office of SP (MT).
5. The successful bidder has to deposit the full amount i.e. tendered amount in the shape of Treasury Challan under the Head of Account "0055 POLICE" within a week from date of issue of acceptance letter failing which the deposited earnest money will be forfeited.

The tyre(s) will be released to the successful bidder immediately on receipt of full amount.

6. In case tender opening day is declared as holiday or bandh call at Itanagar, the tenders shall be received up to next working day till 1100 hrs.
