

TERMS AND CONDITIONS

1. The sale will be "**AS IS WHERE IS BASIS**" and the interested purchasers can inspect the vehicle on any working days from 0930 hrs to 1630 hrs with prior permission of Motor Transport officer, SP Capital Office, Itanagar.
2. Every quotation should clearly state the amount offered (Both in figure and words) along with **2% (Two percent) as earnest money** against reserve price of the condemned vehicle to be deposited in shape of Demand Draft in favour of Superintendent of Police (Capital), Itanagar encashable at any Nationalized Bank of India.
3. The Earnest money of successful bidders shall be refunded on payment of tender money in full while that of the unsuccessful tenders shall be released on the completion of auction process.
4. The interested bidders may put their quotations in the Tender Box kept at SP Capital, Itanagar during office hours w.e.f. **28/11/2022 to 28/12/2022**. The wax sealed cover envelop should clearly be marked "**QUOTATION FOR CONDEMNED VEHICLES**" and addressed to the Superintendent of Police (Capital), Itanagar, Arunachal Pradesh. The sealed quotation will be opened on **29/12/2022 at 1100 hours** and interested bidders may present at the time of opening of the quotation in the office of the SP Capital, Itanagar.
5. The successful bidders have to deposit the full amount i.e. tendered amount in the shape of Treasury challan under the **Head of Account "0055 POLICE"** within a week from the date of issue of acceptance letter failing which the deposited earnest money will be forfeited. The vehicle(s) will be released to the successful bidder(s) immediately on receipt of the full amount.
6. The quoted/bid amount of the vehicle must not be less than that of the Reserve price as mentioned for each vehicle.
7. In case tender opening day is declared as holiday or bandh call at Itanagar, the tenders shall be received up to next working day till 1100 hrs.
