The sealed tender should be dropped in the tender box in the office of Directorate, of Fire & Emergency Services, Ganga, Itanagar w.e.f. 04/01/2023 to 16/01/2023 till 5.00 PM on all office working days duly subscribed "Tender for purchase of condemned vehicle of F&ES". Sealed quotations will be opened on 17/01/2023 at 1100 hrs in the Directorate, of Fire & Emergency Services, Ganga, Itanagar. The representative of the tender may present at the time of opening of the tender.
2. The Tenderer should clearly mention the BID AMOUNT of offer in Figure and Words against the vehicle separately for each vehicle. Quotations must be accompanied with 10% (ten percent) as Bid Security (Earnest Money) against reserved price of each vehicle in the form of Demand Draft in favour of Superintendent of Police, Fire & Emergency Services, Itanagar to be drawn at SBI, Itanagar. The quotation will be rejected in case of earnest money is not deposited with Tender.
3. The Earnest money of successful bidder shall be refunded on payment of bid money in full. While that of unsuccessful Tenderer the same shall be released on completion of the auction.
4. The bid/quoted amount should not be less than the reserve price.
