

TERMS AND CONDITIONS


1. The Limited Tender must be enclosed in suitable cover which must be sealed and superscripted "Quotations for WT equipment". Tenderer may drop their tenders to tender box in the Office of the Supdt. of Police (Telecom), Chimpu during office hours. Tender should be addressed to the undersigned by designation and not by name. Name of item, Quantity, Amount, Tender fee & Earnest Money Deposit are as under:

2. Specification of item is attached as Annexure - A
3. The Limited Tenders will be received from ~~10/01/2025~~ 10/01/2025 0930 hrs to ~~21/01/2025~~ 21/01/2025 1100 hrs and opened publicly in the office chamber of IGP(Admn), PHQ Itanagar on ~~21/01/2025~~ 21/01/2025 at 1130 Hours. If the office remains closed on the scheduled day for any valid reason, the tender will be opened on the next working day at the same time and at the same venue. Tenders received beyond stipulated time shall not be entertained. The tenderers or their authorized (with authorization proof) representative have the liberty to be present during the opening of tender.
4. All the tender must be accompanied with tender fee of Rs.1000/- and earnest money @ 2(two) percent of the estimated cost of the items in the form of Demand Draft from any of the commercial banks in an acceptable form pledged in favour of Supdt. of Police (Telecom), Chimpu. The earnest money deposit is normally to remain valid for a period of forty-five days beyond the final bid validity period. Tenders without tender fee & earnest money will be summarily rejected. Bid security should be refunded to the successful bidder on receipt of performance security & Execution of deed of Agreement.
5. Successful tenderers will be required to furnish 5% of the total value of the items to be supplied as Performance Security & execute the "Deed of Agreement" stipulating the terms and conditions of the contract within 15 days from the date of issue of letter of acceptance of tender. Security deposit will be subject to forfeiture in case of non fulfilment of any or all the terms and conditions of the contract. Earnest money of the successful tenderers will be forfeited by the Government in case of failure to furnish security money and execution of Deed of Agreement. The performance security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.
6. Successful tenderers have to supply the items within 90(ninety) days from the date of issue of Supply order failing which 5 % of Performance Security deposit will be forfeited and supply order will be cancelled OR sum equivalent to 0.5 % of delivery price of the delayed items for each week delayed or part thereof beyond the original contract delivery period will be recovered to a maximum of 10 % as a liquidated damages.
7. Any breakage or loss of any items en-route or in transit will be at the supplier's risk.
8. If any item is found damaged or otherwise unacceptable at the time of delivery/ inspection, the suppliers will be required to replace the same at SP (Telecom) Office, Chimpu, Itanagar, Arunachal Pradesh within 15 days at their own cost.
9. Rate should be quoted F.O.R. SP (Telecom), Chimpu, Itanagar Arunachal Pradesh. Rate quoted other than F.O.R SP (Telecom) Office, Chimpu, Itanagar shall not be accepted, no packing or forwarding charges will be allowed. The rate of item along with GST shall be indicated by the tenderers in Indian currency both in figure and words clearly. Tenders must be eligible and clear in all respect else the tenders shall be liable to be rejected,

10. **Payment will be made to the supplier directly on Acceptance of stores by the government nominated Verification Committee .**
11. The Director General of Police, Itanagar, and Arunachal Pradesh reserves the right to reject the lowest or all or any of the tenders without assigning any reason thereof.
12. The tenders must be accompanied with tender fee , Earnest Money , attested copies of GST registration certificate, valid trading licence ,PAN Card,Income tax return of last 03 years,Undertaking that the item is not a Made in China or anyway related to Chinese firm, OEM authorisation certificate & TEC/ISO Certified Lab test Certificate of 5G Bandpass filter of without which the firm would be out rightly rejected.
13. The tenderers should sign in every page of the tender bearing rates. Similarly, the tenderers should also authenticate all correction of rate/ items in the tender, if any.
14. Quantities mentioned in the enclosure are all approximation and subject to variation as per actual availability of fund.
15. **Tender will remain valid up to 31.03.2025**
16. The Superintendent of Police of Arunachal Pradesh, Itanagar shall have the right to ask the firms to demonstrate their items before the items are accepted. Firms qualified in initial scrutiny shall provide a practical demonstration of equipment in compliance with the specification of tender for Technical evaluation .
17. **All items to be supplied shall be on warranty for 12months a period from the date of Acceptance of Stores by government nominated verification committee.**
18. If any dispute arises out of this contracting agreement the same shall be brought before the Guwahaty High court ,Itanagar Bench at Yupia having appropriate jurisdiction over the matter and whose decision shall be final and binding to the parties to this contract.
19. Proper Index shall be made for all the submitted documents. Each document shall have page number at the top right hand side as indicated in Index page. Documents not mentioned in the Index page will be treated as not submitted.



DEED OF AGREEMENT

This agreement is made onbetween the..... hereinafter called the FIRST PARTY (which term includes their authorized representative) and the Governor of Arunachal Pradesh, represented by Supdt. Police (Telecom) on behalf of Director General of Police, Arunachal Pradesh having his office at Itanagar, 791113, District Papum - Pare hereinafter called the SECOND PARTY (which includes his successors, assignees, executors and WHEREAS SECOND PARTY has placed the order for supply of videArunachal Pradesh Police Headquarters Supply order No.datedand the FIRST PARTY has accepted the said supply order.

Terms and Conditions -

1. The FIRST PARTY agrees to supply the items **within 90 days** from the date of receipt of Supply Order.
2. That the FIRST PARTY agrees that in the event of failure, declining, neglecting or delaying intentionally to comply with the terms and conditions of Agreement, the SECOND PARTY will be at liberty to cancel the supply order and forfeit the security deposit and initiate legal proceedings.
3. A sum equivalent to 0.5% of the delivery price of the delayed items for each week delay or part thereof beyond the original contract delivery period will be recovered by SECOND PARTY up to a maximum of 10% as Liquidated Damages.
4. The FIRST PARTY agrees to deposit 5 % of the total value of the contract as SECURITY DEPOSIT in the Form of Irrevocable Bank Guarantee of any Nationalized Bank pledged in favour of the SECOND PARTY at the time of signing this agreement valid for a period of 60 days beyond warranty period (i.e Warranty period + 02 months handling) from the date of receipt of stores to ensure satisfactory performance of the No interest shall be paid by the SECOND PARTY to FIRST PARTY on such deposits.
5. The SECOND PARTY agrees to release the performance security to FIRST PARTY after 02(two) months from the end of Warranty period obtaining satisfactory reports indicating that no manufacturing defects or variation from approved sample have been detected.
6. The FIRST PARTY agrees to supplyat the location mentioned in the supply order without any additional cost , cess , road taxes etc.
7. The FIRST PARTY shall submit the bills along with delivery Challan within a period of 15 days from the date of delivery of the goods.
8. The FIRST PARTY agrees to provide warranty of minimum 02 years on items which will be supplied to the SECOND PARTY from the date of Acceptance of Stores by government nominated verification committee(except for the consumable items).
9. In case of any disputes ,arbitration shall be held in District Session Court, Yupia(Arunachal Pradesh) or such other place as the DGP (A.P) at his discretion may determine and conduct in accordance with the provision of arbitration and conciliation Act,1996 or any statutory modification or re-enactment thereof . In this clause , the expression DGP Arunachal Pradesh includes if thereby DGP is on leave or absent from duty or is not available for any reason whatsoever , the officer who is looking after the current duties of DGP Arunachal Pradesh whether in addition to other function or otherwise .
